Fund Manager Comment

On a MoM basis, the Fund generated an annualized returned of 23.82% as of 30th April 2023 while the Fund's benchmark recorded an annualized return of 26.29%. The Central Bank kept policy rates unchanged in April in order to uphold tight monetary conditions to continue in its disinflation process. However, market interest rates witnessed higher volatility due to the uncertainty over a possible domestic debt restructure. Inflation (CCPI) fell to 35.3% as at April 2023 mainly owing to the steep fall in food inflation. Treasury bill yields which started to decline further during the month increased during the 2nd half of the month as the 3,6 and 12 month bills ended at 25.74%, 25.27% and 23.00% respectively at the last auction for the month. This was mainly attributed to the government postponing the announcement of the debt restructure program to the following month.
