Fund Manager Comment

On a MoM basis, the Fund generated an annualized returned of 24.20% as of 30th Sept 2022 while the Fund's benchmark recorded an annualized return of 21.60%. Market interest rates remained at it's elevated levels as investors remained sceptic over a possible domestic debt restructure. Inflation (CCPI) rose to 69.8% as at September, mainly driven by the non-food category. Treasury bill rates which peaked to all-time high levels last month, declined marginally during September as the 3-month, 6-month and 12-month bill rates ended at 31.94%, 30.59% & 29.85% respectively at the last auction of the month. Foreign Holdings on government securities which remained subdued, saw a significant increase as foreign investors increased their exposure to government securities from 4.1 Bn to 22.1 Bn during the month.
