


Monthly Report | Oct-2024

Fund Manager Comment

During Oct 2024, the fund generated an annualized return of 6.87%. On the Shariah front, Mudarabah and Wakala rates have declined in line with conventional rate drop witnessed during past few months and remained at low levels during Oct 2024. On the conventional front, Treasury bill yields generally declined in the first three auctions, falling by 1.17%, 1.07%, and 0.10% for 3-month, 6-month, and 12-month tenors. During the 4th auction, rates remained steady and during the last auction of Oct 2024, short-term yields increased slightly, with the 91-day and 182-day tenors rising by 3 basis points each, while the 364-day rate held steady at 9.95%. In the secondary market, market participants booked profits during the month. Buying interest remained sporadic, which were subsequently met with selling pressure to make profits. Shariah rates are anticipated to remain low in the short term. There was no Monetary Policy Review in Oct 2024 and the CBSL is to carry out its next Monetary Policy Review on 27 Nov 2024. *Source: SFAM and CBSL*


